Rules: All wrestlers must have a USA wrestling card. Headgear is mandatory. Coaches and wrestlers will be the **ONLY** people allowed matside. KSHSAA rules will apply with KKWF adoptions. All age divisions will wrestle folk style. Medals will be given for 1st through 4th places in all age and weight divisions.

10 and under: 52, 55, 58, 61, 64, 67, 70, 73, 76, 79, 82, 85, 90, 95, 100, 110, 120, 130, HWT*

12 and under: 60, 64, 68, 72, 76, 80, 84, 88, 92, 96, 100, 105, 110, 115, 120, 125, 130, 140, 150, 165, HWT*

* Include EXACT weight for all Heavy-weight wrestlers.
We reserve the right to combine brackets when necessary.
