The camp is open to wrestlers who are at least 10 years of age on the first day of camp to those wrestlers entering their senior year of HS.

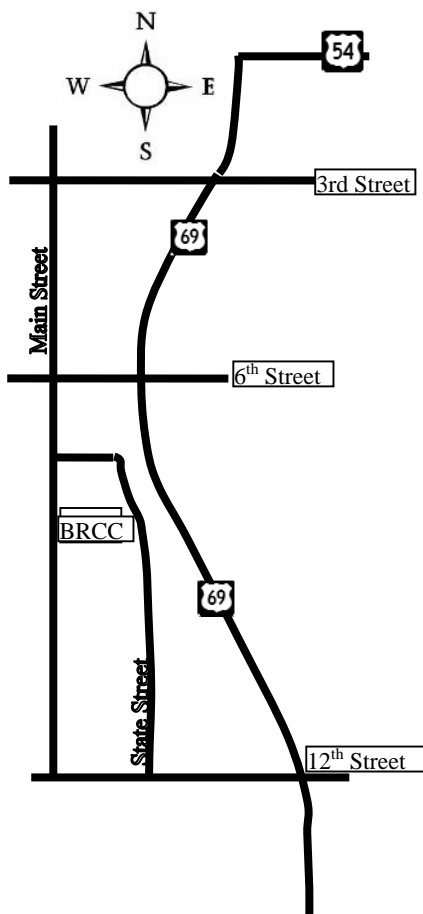
Coaches of any level are welcome at any or all sessions at no cost.
